



EXECUTIVE ORDER NO. 44 – 2025

**AN ORDER ESTABLISHING GUIDELINES FOR THE CASH FOR
WORK PROGRAM FOR DISASTER VICTIMS AND
VULNERABLE SECTORS UNDER THE LOCAL DISASTER RISK
REDUCTION MANAGEMENT FUND OF THE CITY OF LAPU-
LAPU**

WHEREAS, the City of Lapu-Lapu has a Cash for Work Program under its Local Disaster Risk Reduction Management Fund, which aims to provide victims of disasters with the means to earn an income immediately after a disaster;

WHEREAS, there is a need to provide immediate assistance to households and / or individuals severely affected by a disaster in order to help them recover from the effects of the disaster;

NOW THEREFORE, by virtue of the powers vested in me by law, I, **MA. CYNTHIA "CINDI" K. CHAN**, City Mayor of Lapu-Lapu City, do hereby establish the guidelines for the Cash for Work Program for Disaster Victims and Vulnerable Sectors under the Local Disaster Risk Reduction Management Fund in the City of Lapu-Lapu subject to the following conditions:

1. Any person, who is a bona fide resident of the City of Lapu-Lapu and who is a victim of a natural or man-made disaster, shall be qualified to be a beneficiary of this program;
2. Under the Cash for Work Program, a qualified beneficiary may perform any of the following activities:
 - a. Repacking of relief goods;
 - b. Assist in the transport of relief goods;
 - c. Distribute relief goods;
 - d. Clearing and cleaning activities in public roads, streets, and public facilities;
 - e. Assist in the implementation of disaster risk reduction & climate change adaptation program; and
 - f. Other activities as may be directed by the Lapu-Lapu City Disaster Risk Reduction and Management Office
3. A qualified beneficiary shall be entitled to receive the prevailing daily minimum wage in Central Visayas for every day he/she has performed any of the activities mentioned in the previous paragraph;

4. All expenses incurred for the implementation of the Cash for Work Program shall be charged to Cash for Work – Disaster Victims & Vulnerable Sectors Account Code No. 9998-5-02-99-990-1

This Executive Order shall take effect immediately and shall remain in force unless otherwise superseded or modified by subsequent Executive Orders and other issuances.

Let copies of this Executive Order be furnished to the Disaster Risk Reduction and Management Office, the City Budget Office, the City Accountant's Office, and the City Treasurer's Office for their information and guidance.
