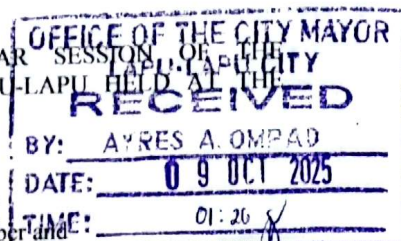

RESOLUTION NO. 17-0610-2025

A RESOLUTION APPROVING AND AUTHORIZING THE DONATION, CHARGED TO THE REVISED 2025 REPROGRAMMED UNEXPENDED BALANCE OF THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF), TO THE MUNICIPALITIES OF SOGOD, BORBON, TABOGON, MEDELLIN, DAANBANTAYAN, SAN REMIGIO AND TABUELAN WHO WERE GRAVELY AFFECTED BY THE 6.9 MAGNITUDE EARTHQUAKE ON SEPTEMBER 30, 2025

WHEREAS, on the evening of September 30, 2025, a 6.9 magnitude earthquake struck the Province of Cebu and was felt in several local government units, especially the northern part of the Province of Cebu, where casualties and damages to property were reported;

WHEREAS, the said tragic event has claimed lives and caused fear, loss, and suffering to many families, leaving a profound impact on the affected communities;

WHEREAS, the Sangguniang Panlungsod of Lapu-Lapu City, deems it fitting and proper to express solidarity with the victims and extend heartfelt condolences to the bereaved families;

WHEREAS, as part of its moral and social responsibility, the City of Lapu-Lapu recognizes the importance of extending assistance to fellow local government units within Cebu Province during times of calamity and disaster;

WHEREAS, the City Government, through its City Disaster Risk Reduction and Management Office (CDRRMO), has already mobilized resources, manpower, and expertise to support search, rescue, relief, and recovery operations the past week;
