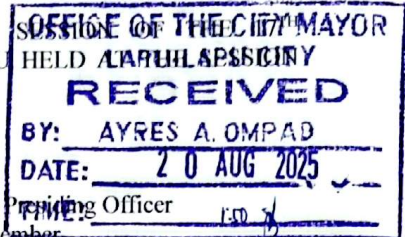

RESOLUTION NO. 17-0240-2025

A RESOLUTION APPROVING THE 2025 REPROGRAMMED UNEXPENDED BALANCE OF THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF) AMOUNTING TO SIXTY-FOUR MILLION SIX HUNDRED NINETY-FIVE THOUSAND TWO HUNDRED THREE PESOS AND FORTY-ONE CENTAVOS (P64,695,203.41) AND TO SUPPLEMENT THESE APPROVED PROGRAMS, PROJECTS AND ACTIVITIES (PPA) TO THE ANNUAL INVESTMENT PLAN (AIP) FOR 2025

WHEREAS, Section 21 of RA No. 10121, Philippine Disaster Risk Reduction Management Act, provides that Local Calamity Fund shall henceforth be known as LDRRMF. Not less than 5% of the estimated revenue of the City from the regular sources shall be set aside for LDRRMF. (NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-01 dated March 25, 2013;

WHEREAS, unexpended LDRRMF shall accrue to a Special Trust Fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction Management Council (LDRRMC) within the next five years;

WHEREAS, unexpended LDRRMF balance must be reprogrammed annually to support the Programs, Projects and Activities (PPAs) aimed at disaster risk reduction and climate change adaptation;

WHEREAS, the reprogrammed LDRRMF shall be a new Annual Investment Plan or financial plan which provides detail Programs, Projects and Activities;

WHEREAS, the PPAs under the new AIP shall be prepared by the local DRRM Office which are aimed to address the prevailing hazards of the community;

WHEREAS, the reprogrammed LDRRMF AIP must be reviewed and approved by the Lapu-Lapu City DRRM Council before it shall be forwarded to the Local Development Council and Sangguniang Panlungsod for review and concurrence;

WHEREAS, the City Accounting Office certified the availability of unspent balance in the LDRRMF Trust Fund amounting to Sixty-Four Million Six Hundred Ninety-Five Thousand Two Hundred Three Pesos and Forty-One Centavos (P64,695,203.41) that is due for reprogramming through Supplemental AIP for 2025;

WHEREAS, the LDRRMO have approved the proposed Annual Investment Plan for the reprogrammed LDRRMF of 2025 amounting to P64,695,203.41. The amount includes the purchase of ready to wear clothes for fire victims and other human induced disasters in the amount of One Million Five Hundred Thousand Pesos (P1,500,000.00). There is a proposed ordinance giving clothing subsidy to the said fire victims and disaster victims.

NOW THEREFORE, on motion of Hon. Marciano A. Alforque, Jr. duly seconded by Hon. Rufo Y. Bering and Hon. Joseph T. Pangatungan,

RESOLVED, as it is hereby being resolved, to approve the 2025 unexpended balance of the Local Disaster Risk Reduction Management Fund (LDRRMF) except for item 1.11 in the amount of P1.5 million for the purchase of ready-to-wear clothes for the fire victims and human induced disasters.

RESOLVED FURTHER, to allocate One Million Five Hundred Thousand Pesos (P1,500,000.00) for the proposed clothing subsidy for these fire victims and other induced disasters.

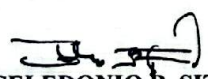
