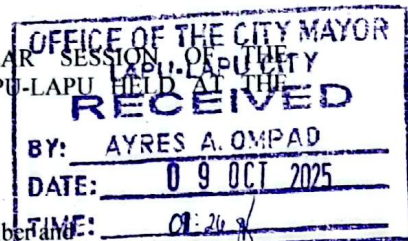

**RESOLUTION NO. 17-0609-2025**

**A RESOLUTION APPROVING THE REVISED 2025 REPROGRAMMED UNEXPENDED BALANCE OF THE LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF) AMOUNTING TO SIXTY-FOUR MILLION SIX HUNDRED NINETY-FIVE THOUSAND TWO HUNDRED THREE PESOS (P 64,695,203.00) AND TO SUPPLEMENT THE APPROVED PROGRAMS, PROJECTS AND ACTIVITIES (PPA) TO THE ANNUAL INVESTMENT PLAN (AIP) FOR 2025**

WHEREAS, for the unexpended balance of the LDRRMF to be released and utilized for new expenditures, JMC No. 2013-1 issued by the Department of Budget and Management (DBM), National Disaster Risk Reduction Management Council (NDRRMC) and the Department of Interior and Local Government (DILG) requires that a revised Annual Investment Plan be approved by the Local Sanggunian and the Local Chief Executive upon the recommendation of the LDRRMF;

WHEREAS, on August 13, 2025, the Sangguniang Panlungsod, approved Resolution No. 17-0240-2025, A Resolution Approving The 2025 Reprogrammed Unexpended Balance of the Local Disaster Risk Reduction Management Fund (LDRRMF);

WHEREAS, in light of the 6.9 Magnitude Earthquake that hit Cebu and gravely affected the northern part of the province, the City Disaster Risk Reduction and Management Council (CDRRMC), on a meeting held on October 7, 2025, through Resolution No. 10-07-s25, has approved the revision of the 2025 Reprogrammed Unexpended Balance of the Local Disaster Risk Reduction Management Fund (LDRRMF) to be able to extend additional donations to the gravely affected areas;

WHEREAS, the revision shall amend the appropriations of Project 6.4- "Rehabilitation and Improvement of Lapu-Lapu City Emergency Management Building (Gun-ob Fire Station)- Phase 1" amounting to Twenty -Five Million Pesos (P 25,000,000.00), it shall now be Nineteen Million Two Hundred Thousand Pesos (P 19,200,000.00);

WHEREAS, an additional project is included, Project 6.5- "Donation for Local Government Units Affected by the Magnitude 6.9 Earth Quake in Northern Cebu Specifically the Municipalities of Sogod, Borbon, Tabogon, Medellin, Daanbantayan, San Remigio and Tabuelan" in the amount of Five Million Eight Hundred Thousand Pesos (P 5,800,000.00);

NOW THEREFORE, on motion of Hon. Annabeth D. Cuizon duly seconded en masse,

RESOLVED, to approve the Revised 2025 Reprogrammed Unexpended Balance of the Local Disaster Risk Reduction Management Fund (LDRRMF) Amounting to Sixty-Four Million Six Hundred Ninety-Five Thousand Two Hundred Three Pesos (P 64,695,203.00) and to Supplement the Approved Programs, Projects And Activities (PPA) To The Annual Investment Plan (AIP) For 2025;

RESOLVED FURTHER, to request the Secretary to the Sangguniang Panlungsod of the City of Lapu-Lapu to furnish copies of this resolution to the Office of the Mayor, the CDRRM, and the Office of the City Accountant for their information and guidance.
