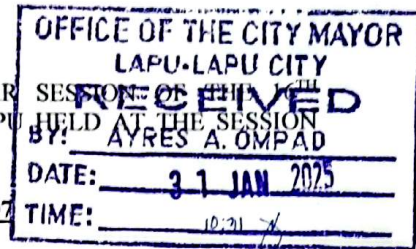

**A RESOLUTION DECLARING THE SPORADIC FIRE INCIDENTS IN THE
DIFFERENT AREAS OF BARANGAYS GUN-OB, BASAK, BUAYA AND
CANJULAO, ALL OF LAPU-LAPU CITY AS SEVERELY AFFECTED
DISASTER AREAS**

WHEREAS, sporadic fire incidences occurred in the different areas of the City of Lapu-Lapu on the months of September and October, 2024;

WHEREAS, the City of Lapu-Lapu thru City Ordinance No. 16-119-2023 provides for a rental subsidy in the amount of Five Thousand Pesos (P5,000.00) per month for a maximum of three months to eligible beneficiaries who are victims of fire and other human induced disasters;

WHEREAS, the Sangguniang Panlungsod of the City of Lapu-Lapu needs to declare the area affected by the sporadic fires as "severely affected disaster areas" in order to process the rental subsidy for the eligible fire victims, pursuant to Ordinance No. 16-119-2023;

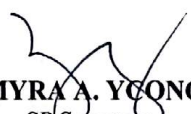

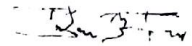

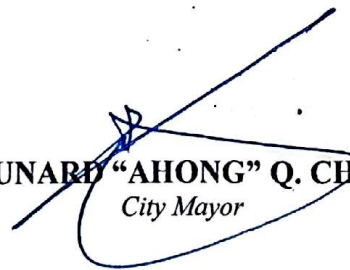
