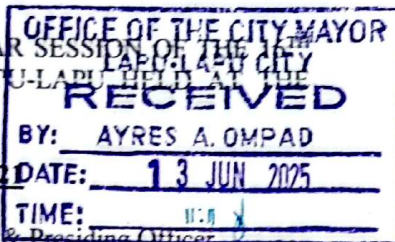

RESOLUTION NO. 16-4434-2025

**A RESOLUTION DECLARING SPORADIC FIRE INCIDENTS THAT OCCURRED
IN SITIO IBA, BARANGAY BASAK, AND IN PUROK LUBI, BARANGAY
CANJULAO, ALL OF THIS CITY, ON MAY 30, 2025, AS SEVERELY
AFFECTED DISASTER AREAS**

WHEREAS, sporadic fire incidents occurred at around 9:47 AM in Sitio Iba, Barangay Basak and in Purok Lubi, Barangay Canjulao at around 10:06 AM, all of this City, on May 30, 2025, resulting in widespread damage to properties, displacement of residents, and disruption of economic activities;

WHEREAS, according to the report from the City Social Welfare and Development Office, there were thirty (38) total affected families and equivalent to one hundred seventy-nine (179) individuals of the fire incident;

WHEREAS, the City of Lapu-Lapu thru City Ordinance No. 16-119-2023 provides for a rental subsidy in the amount of Five Hundred Pesos (5,000.00) per month for a maximum of three months to eligible beneficiaries who are victims of fire and other human induced disasters;

WHEREAS, the Sangguniang Panlungsod of the City of Lapu-Lapu needs to declare the area affected by the fire as "severely affected disaster area" in order to process the rental subsidy for the eligible fire victims, pursuant to Ordinance No. 16-119-2023;

WHEREAS, The City Disaster Risk Reduction Management Council has recommended thru CDRRMC Resolution No. 06-02-s25 dated June 02, 2025, the declaration of the two (2) fire incidents occurred on May 30, 2025, at 9:47 AM, in Sitio Iba, Barangay Basak and at 10:06 AM in Purok Lubi, Barangay Canjulao, all of this City, as Severely Affected Disaster Areas;

NOW THEREFORE, on motion of Hon. Marciano A. Alforque, Jr. duly seconded en masse,

RESOLVED, as it is hereby being resolved, to declare sporadic fire incidents that occurred in Sitio Iba, Barangay Basak and in Purok Lubi, Barangay Canjulao, all of this City, on May 30, 2025, as Severely Affected Disaster Areas.

RESOLVED FURTHER, that copies of this resolution be furnished, the City Mayor, the Disaster Risk Reduction Management Office (DRRMO), Barangay Basak, Barangay Canjulao and others concerned, for information and guidance.

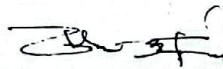

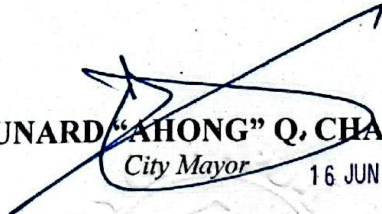
