

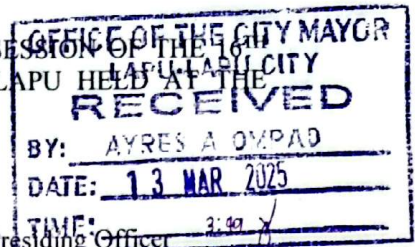

RESOLUTION NO. 16-4107-2025

**A RESOLUTION DECLARING SPORADIC FIRE INCIDENT THAT OCCURRED
IN SITIO MASULOG, BARANGAY BASAK, LAPU-LAPU CITY, ON
MARCH 11, 2025, AS SEVERELY AFFECTED DISASTER AREA**

WHEREAS, a sporadic fire incident occurred in Sitio Masulog, Barangay Basak, Lapu-Lapu City, on March 11, 2025, at 12:30 PM, resulting in widespread damage to properties, displacement of residents, and disruption of economic activities;

WHEREAS, according to the report from the City Social Welfare and Development Office, there were eighteen (18) total affected families and equivalent to eighty (80) individuals of the fire incident;

WHEREAS, the City of Lapu-Lapu thru City Ordinance No. 16-119-2023 provides for a rental subsidy in the amount of Five Hundred Pesos (5,000.00) per month for a maximum of three months to eligible beneficiaries who are victims of fire and other human induced disasters;

WHEREAS, the Sangguniang Panlungsod of the City of Lapu-Lapu needs to declare the area affected by the fire as "severely affected disaster area" in order to process the rental subsidy for the eligible fire victims, pursuant to Ordinance No. 16-119-2023;

WHEREAS, The City Disaster Risk Reduction Management Council has recommended thru CDRMC Resolution No. 03-11-S25 dated March 11, 2025, the declaration of the fire incident occurred on March 11, 2025, 12:30 PM, at Sitio Suba-Masulog, Barangay Basak, Lapu-Lapu City as Severely Affected Disaster Area;

NOW THEREFORE, on motion of Hon. Marciano A. Alforque, Jr. duly seconded en masse,

RESOLVED, as it is hereby being resolved, to declare sporadic fire incident that occurred in Sitio Masulog, Barangay Basak, Lapu-Lapu City, on March 11, 2025, as Severely Affected Disaster Area.

RESOLVED FURTHER, that copies of this resolution be furnished, the City Mayor, the Disaster Risk Reduction Management Office (DRRMO), Barangay Basak, and others concerned, for information and guidance.

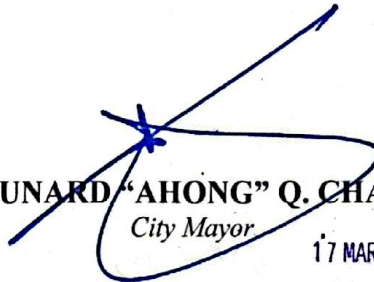
