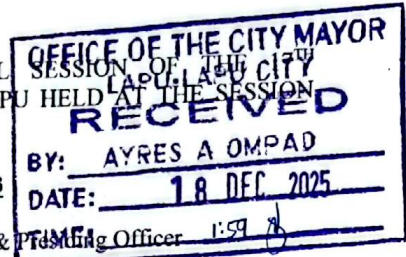

AN RESOLUTION APPROVING THE REPROGRAMMING OF THE UNSPENT 2024 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) TRUST FUND AMOUNTING TO SIX MILLION PESOS (P6,000,000.00)

WHEREAS, the City Government of Lapu-Lapu has an Unspent 2024 Local Disaster Risk Reduction and Management Fund (LDRRMF) Trust Fund amounting to Six Million Pesos (P6,000,000.00), which remains available for reprogramming;

WHEREAS, the said fund was originally allocated for the repair of the Caohagan Barangay Hall, but the project was already completed through the Local Development Fund (LDF), resulting in the availability of the LDRRMF trust fund balance for alternative DRRM-related expenditures;

WHEREAS, the Lapu-Lapu City Disaster Risk Reduction and Management Council (LDRRMC), through Resolution No. 10-15s25, recommended the reprogramming of the said amount for several priority disaster risk reduction and management projects of the City;

WHEREAS, the proposed funded activities are all within the allowable spending provisions for the LDRRMF and are necessary to strengthen the City's disaster preparedness, response capacity, emergency management infrastructure, and operational efficiency;

NOW THEREFORE, on motion of Hon. Annabeth D. Cuizon duly seconded by Hon. Climaco A. Tatoy, Jr., Hon. Marciano A. Alforque, Jr. and Hon. Celestino C. Aying,

RESOLVED, as it is hereby resolved, that the Sangguniang Panlungsod of the City of Lapu-Lapu hereby approves the reprogramming of the Unspent 2024 LDRRMF Trust Fund amounting to ₱6,000,000.00 (Repair and Improvement of Barangay Caohagan Barangay Hall which was devastated by Typhoon Odette) for the following purposes:

1. ₱3,200,000.00 – Construction of the DRRM Warehouse at the Old Market Building near Muelle Osmeña, adjacent to Easa Dialysis Center;
2. ₱2,000,000.00 – Purchase and installation of air-conditioning units for the Lapu-Lapu City Fire District (LCFD) and the City Traffic Management System (CTMS);
3. ₱800,000.00 – Repair of the façade of the Emergency Management Building, DRRMO side, Barangay Gun-ob.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the City Mayor, the City DRRMO, the City Accounting Office, and all concerned agencies for their appropriate action and reference.

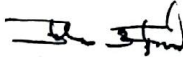
