



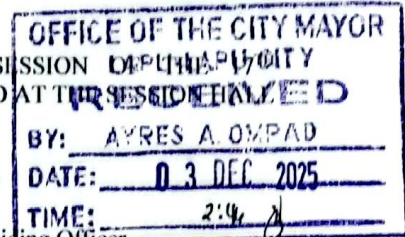

A RESOLUTION DECLARING THE SPORADIC FIRE INCIDENTS IN BARANGAY BASAK, LAPU-LAPU CITY AS SEVERELY AFFECTED DISASTER AREAS THAT AFFECTED SEVENTEEN (17) FAMILIES, TOTALING FORTY-FIVE (45) INDIVIDUALS, CHARGEABLE AGAINST THE RENTAL SUBSIDY PROGRAM FOR VICTIMS OF FIRE AND OTHER HUMAN-INDUCED DISASTER IN THE CITY OF LAPU-LAPU WITH ACCOUNT CODE 9998-5-02-99-080, IN ACCORDANCE WITH CITY ORDINANCE NO. 16-119-2023

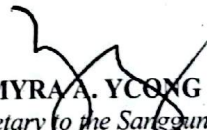
